





### OCEAN ACIDIFICATION, May 2021

- In May 2021 EWA focused on ocean acidification topic. There was a campaign week from 3.-9. May and a web conference was held on 5 and 6 May in the frame of BALSAM project financed by the Swedish Institute. GWP Estonia translated and distributed a summarising article and in addition advertised 5 fact sheets compiled by NGO AcidRain.
- ► The web conference gave a very good overview of recent studies of acidification in the Baltic Sea, Black Sea, Kara Sea and Mediterranian Sea. The conference participants were asked to be ready for a possible joint common project.


### SUMMER EXCURSION TO LAHEMAA

- ▶ On 11 and 12 June 2021, after long pause, the members of EWA were happy to meet again in person in the frame of the traditional two days summer excursion. A number of working or already abandoned ruins of water mills on the rivers of Lahemaa National Park were (re-) examined to discuss the need of opening the free water courses for migratory fish. It was concluded, that the relevant decisions taken by the official authorities (designation of fish protection areas on the relevant rivers) were reasonable and e.g. in the case of the Water Mill in Vihula Manor, the change of the initial protection zone helped to keep the water mill for touristic sightseeing object.
- ▶ ON 12 June morning 3 hours were dedicated to the Annual Meeting to adopt the financial report 2020, to discuss the budget and activity plan for 2021 and to elect new board. The rest of 12 June was dedicated to the summer excursion again.






#### BALTIC SEA DAY CONFERENCE

- ▶ On the last Thursday of August the traditional Baltic Sea Day is held in Tallinn with the support of City Government and the Finnish Institute. Several members of Estonian Water Association took part there. This year the conference took place in the newly opened cruise terminal in the Tallinn Port The modern building is heated with solar panels and the Sea energy (Heat pump). <a href="https://www.ts.ee/en/">https://www.ts.ee/en/</a> The presentations covered a wide range of topics related to climate change, Baltic Sea and floods in the cities. After the presentations an excursion was held on the reconstructed long innovative public promenade on Cruise Quai with cafeterias, children playgrounds, benches and lots of flower beds. A great location for environmental education activities and other events for citizens has been created there.
- ▶ In the evening these was the first casting of a movie about people who collect items washed to the seashore. The cases included Japan, Netherlands and UK (Cornwall), Although the focus was on the strange habit of collecting and sorting the trash for ones enjoyment, the clear message for environmental managers was also said out by the young Finnish author, who held a greeting speech before the show.





#### 2022 Estonia


- ▶ 2 and 3 February 2022. WWF wetland conference on the web.

- 12 to 14 August trip to Island Ruhnu with the active core group of Estonian Water Association, local sanitation cases will be examined.


